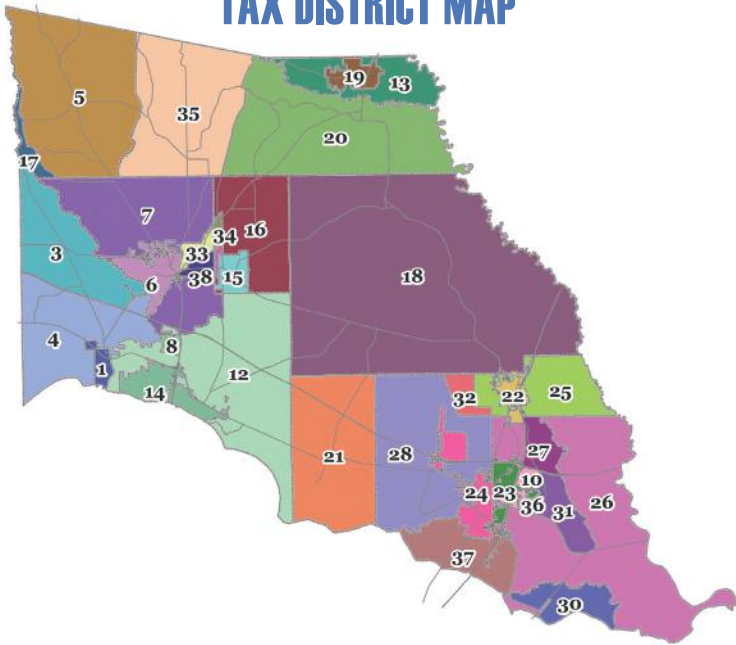

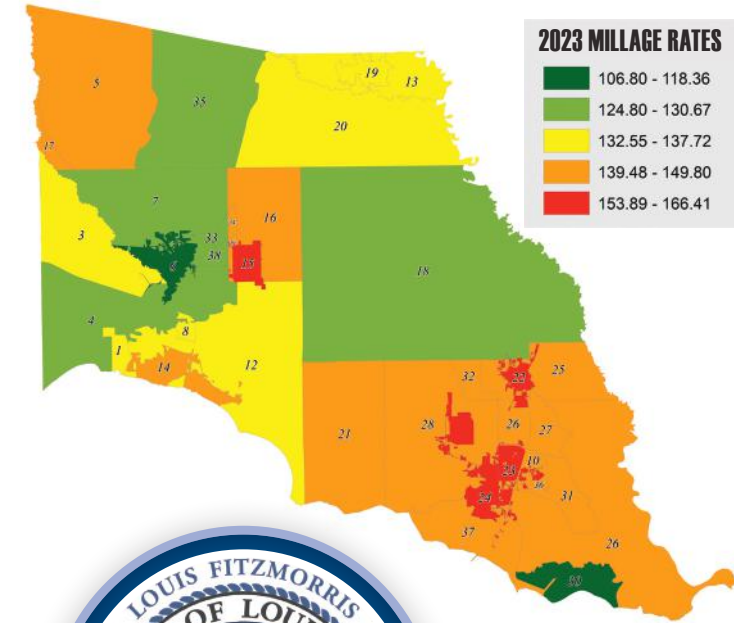
TAX DISTRICT MAP

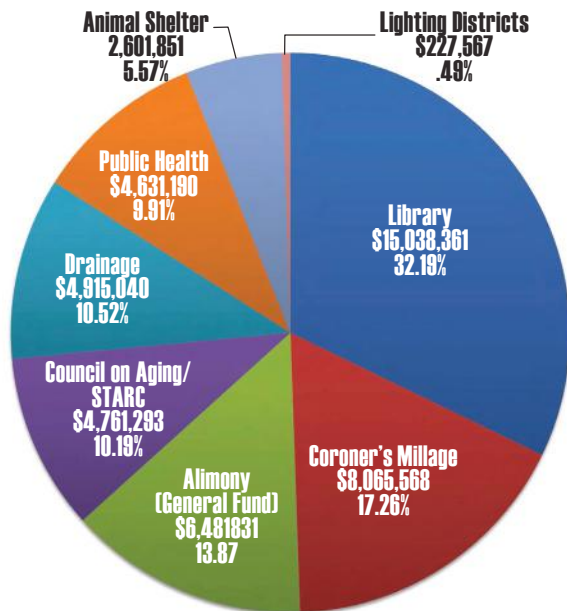

Alimony is for maintenance and means that the dollars go into the general fund and can be used for almost any purpose. As you see, of the total tax revenues the parish receives, 13.87% goes into the parish's general fund.
